TO THE GRAND CRESCENT :

WELCOME ONE AND ALL TO ANOTHER FRATERNAL YEAR. AS YOUR PRESIDENT FOR THE EIGHTH YEAR RUNNING, I CONSIDER IT AN HONOUR TO BE GIVEN YET ANOTHER TERM IN OFFICE; AN OPPORTUNITY TO ACCOMPLISH MANY OF THE GOALS AND AMBITIONS OF THIS FRATERNITY AND IT'S BROTHERS OVER THE PAST FEW YEARS. THOUGH I OCCASIONALLY GET THE FEELING THAT I MAY DIE IN OFFICE, FOR THE MOMENT LET US LOOK AT THE 1993-94 YEAR AND MAKE SOME FIRM DECISIONS WHICH PERTAIN TO OUR IMMEDIATE FUTURE.

ARE WE COMMITTED TO OUR POLICIES / DEDICATION(S) ? ARE WE DETERMINED TO STRENGTHEN THIS FRATERNITY AS A WHOLE BY DOING OUR PART AS INDIVIDUAL BROTHERS ? DOES THE BROTHERHOOD AS A WHOLE HAVE A SET OF CLEAR OBJECTIVES FOR THE NEAR FUTURE ? WILL WE EVER SEE ELEVEN BROTHERS TRAVEL TO CONVENTION IN ONE VEHICLE AGAIN ? THE ANSWERS TO THESE AND MANY OTHER QUESTIONS WILL DETERMINE THE FATE OF THIS GRAND ORGANIZATION. ARE WE UP TO THE TASK ?

I WILL NOW ATTEMPT TO ADDRESS THE ENTIRE BROTHERHOOD, AND ALL ISSUES RELEVANT TO THE FRATERNITY AT THIS TIME, IN ONE ISSUE OF THIS FINE PUBLICATION. IN NO PARTICULAR ORDER.....

CONVENTION 1993

A COMPLETE RUNDOWN OF THE BUSINESS SIDE OF CONVENTION WILL BE RELEASED SOON BY THE CONVENTION SECRETARY, IN THE FORM OF THE OFFICIAL CONVENTION MINUTES. THE LIGHTER SIDE OF CONVENTION IS BEING DOCUMENTED BY THE CONVENTION SERGEANT-AT-ARMS, WHICH WILL APPEAR IN A FUTURE EDITION OF THE GRIP. FOR NOW I WILL LIST SOME IMPORTANT DECISIONS WHICH WERE ARRIVED AT THIS YEAR.

DUES - AS OF CONVENTION '93, GAMMA ETA AND BETA XI CHAPTERS WERE NOT IN ARREARS IN DUES. BETA ALPHA, BETA PI, AND GAMMA ALPHA CHAPTERS WERE, TO VARYING DEGREES. IT WAS DECIDED BY THE DELEGATES THAT ALL CHAPTERS WOULD PAY \$100 BY OCT. 15/93 TO BE ACTIVE THIS YEAR. IT WAS ALSO DECIDED THAT GAMMA ETA AND BETA XI WOULD OWE AN ADDITIONAL \$100 FOR THE 93/94 YEAR. THE CHAPTERS IN ARREARS IN DUES WOULD BE REQUIRED TO PAY \$200 FOR THE REMAINDER OF THE 93/94 YEAR, OR BE DECLARED INACTIVE AT CONVENTION '94. (I HAVEN'T HEARD FROM ANYONE YET)

CONSTITUTION - FIRST OF ALL, THERE WAS A DECISION MADE TO GIVE THE CHAPTERS SOME TIME TO REVIEW THE AMENDMENTS PROPOSED, AND TO THEN RATIFY BY PETITION, BECAUSE THE AMENDMENTS DID NOT RECEIVE 80% MAJORITY OF THE DELEGATES PRESENT (ONLY 3 OF 4 APPROVED). THE PROBLEM WITH THAT DECISION IS THAT AS A RESULT OF THE PREVIOUS DECISION ON DUES, THE ONLY CHAPTERS ELIGIBLE TO VOTE WOULD BE GAMMA ETA AND BETA XI. WE CAN DISCUSS THIS IF THERE IS ANY SERIOUS OBJECTION, BUT THE WAY I SEE IT TODAY, THE CONSTITUTION WAS RATIFIED WHEN GAMMA ETA AND BETA XI APPROVED IT.

TWO AMENDMENTS I WOULD LIKE TO POINT OUT NOW ARE THE RE-INTRODUCTION OF THE NATIONAL BOARD DELEGATE AND THE LITERARY OR MUSICAL PROGRAM. THE FIRST IS A CHAPTER OFFICER THAT IS ELECTED TO SERVE AS THAT CHAPTER'S REPRESENTATIVE TO THE IBC. THIS BROTHER, PREFERABLY AN ALUMNUS, COULD TAKE AN INTERNATIONAL OFFICE OR SIMPLY ACT AS A CONTACT. THE PURPOSE IS SIMPLY TO IMPROVE COMMUNICATIONS. THE SECOND IS MY ATTEMPT TO IMPLEMENT SOME FORMAL MECHANISM FOR "THE DISSEMINATION OF IDEAS BETWEEN YOUNG MEN OF VARYING BACKGROUNDS". EXACTLY WHAT THIS WILL ENTAIL WILL DEPEND ON THE CHAPTERS, BUT IT IS TO BECOME PART OF STANDARD MEETING PROCEDURE FOR NOW. THE IDEA IS THAT THE CHAPTER IS GIVEN AN ITEM FOR DISCUSSION (SOMETHING LITERARY OR MUSICAL) AND HAVE THIS LEAD WHERE IT MAY. I'LL BE DISCUSSING THIS MORE IN FUTURE.

INTERNATIONAL BOARD OF CONTROL 1993-94 - THE PRESENT OFFICER LIST LOOKS LIKE THIS:

PRESIDENT - EDWARD J. DECKER
N. VICE-PRESIDENT - CHRIS BURNIP
VP EXPANSION - JUSTIN NELSON
N. SECRETARY - KERRY DECKER
HISTORIAN - CHRIS LAUBACH

IN ADDITION, BROTHERS MICHEAL ECKSTEIN AND ROBBIE PEDEN AGREED TO ACT AS INTERNATIONAL REPRESENTATIVES FOR BETA ALPHA

AND BETA PI CHAPTERS RESPECTIVELY; AND BROTHER RON KITA IS ACTING AS BOARD OF TRUSTEE CHAIRMAN UNTIL A MEETING CAN BE HELD.

BOARD OF TRUSTEES - AT THE CONVENTION 4 BROTHERS WERE ELECTED TO SERVE AS TRUSTEES. THEY ARE: RON KITA, MARK LAMINMAN, MICHEAL KUCH AND BILL SCHMITT. FOR NOW WE SHOULD ESTABLISH CONTACT AMONGST OURSELVES AND DECIDE HOW TO APPROACH THE NEW YEAR. I AM ALWAYS OPEN FOR SUGGESTIONS FOR TRUSTEE MEMBERS, ESPECIALLY FROM THE SOUTH, SO KEEP IT IN MIND.

THE TRUST FUND - AGAIN AT THIS YEAR'S CONVENTION, THE DELEGATES MADE A FORMAL DECLARATION IN REGARDS TO THE TRUST FUND (AS WAS DONE AT CONVENTIONS 88 AND 90). THIS YEAR'S RESOLUTION IS A BIT DIFFERENT THAN THE PREVIOUS ONE. IT IS WORDED AS FOLLOWS:

"WE, THE UNDERSIGNED, HAVE VOTED UNANIMOUSLY TO HAVE THE FRATERNITY'S TRUST FUND TURNED OVER TO THE INTERNATIONAL PRESIDENT, EDWARD J. DECKER, BECAUSE THE PRESENT SIGNATORIES TERMS AS TRUSTEES HAVE EXPIRED, AND ACCORDING TO ARTICLE 8, PART C, SECTION 4, THE DELEGATES CAN BY UNANIMOUS VOTE USE THIS FUND FOR EMERGENCY PURPOSES.

THE DELEGATES PRESENT AT GAMMA DELTA PSI'S ANNUAL CONVENTION ON JULY 30, 31 AND AUGUST 1, IN VIRGINIA, U.S.A., HAVE VOTED ON AND AGREED TO THE ABOVE." (SIGNED BY BETA ALPHA, BETA XI, BETA PI, AND GAMMA ETA, AUGUST 1, 1993.)

I'LL RETURN TO THIS TOPIC LATER IN THIS REPORT.

LASTLY - AWORD ON ATTENDANCE. HOW CAN GAMMA ETA WIN THE ATTENDANCE AWARD IN VIRGINIA AGAIN ? HOW CAN TWO CARLOADS FROM GAMMA ALPHA COMBINE TO ATTEND HALF OF ONE MEETING ? HOW COULD BETA PI BE ABSENT ON SATURDAY ? I COULD GO ON, BUT MY POINT IS SIMPLY THAT IF WE CANNOT MEET AS A WHOLE FRATERNITY AT LEAST ONCE A YEAR, THEN WE MIGHT JUST AS WELL SCRAP THE INTERNATIONAL. CONVENTION IS FOR THE CHAPTERS, NOT THE IBC.

PUBLICATIONS

THE GRIP - THE NEXT EDITION WILL GO OUT IN EARLY DECEMBER, SO IF ANYONE IS INTERESTED IN SUBMITTING SOMETHING, FEEL FREE. I WILL CONTINUE TO PUT OUT THE GRIP AS LONG AS I RECEIVE SOME RESPONSE FROM THE CRESCENT THAT IT IS BEING READ AND SERVING A PURPOSE. SO I CHALLENGE Y'ALL TO RESPOND IN THE BEST WAY YOU KNOW HOW. I MEAN IT. REALLY.

THE CONSTITUTION / PLEDGE MANUAL / EXPANSION LEAFLET / LETTERHEAD - IT IS THE INTENTION OF THE IBC TO HAVE THESE ITEMS PRINTED ASAP. THE TEXT OF EACH ITEM HAS ALREADY BEEN

LOADED INTO MY COMPUTER (PS/1, MICROSOFT WORKS & WORDPERFECT) SO WE ARE LOOKING AT COVERS AND PHOTOCOPYING, BASICALLY. TOWARDS THE ACHIEVEMENT OF THIS END I HAVE RECENTLY BEEN ASSISTED BY BROTHER DON SOWCHUCK, WHO ARRANGED FOR AN ESTIMATE ON THE COST OF THE ABOVE STATED ITEMS. UNFORTUNATELY, THE ESTIMATE WAS TOO MUCH FOR US TO CONSIDER, SO I AM PRESENTLY RE-EVALUATING THE TYPE OF WORK WHICH NEEDS TO BE DONE. IF ANY BROTHERS READ THIS THAT COULD ASSIST US IN OUR PRINTING NEEDS, PLEASE GIVE US A CALL.

THE OFFICER'S HANDBOOK / TRADITIONS / HISTORY (TO 1929) - THESE ARE CURRENTLY AVAILABLE TO ALL WHO WOULD TAKE THE TIME TO EDUCATE THEMSELVES FURTHER ON THIS FRATERNITY OF OURS, SUCH AS BROTHER JOHN COBB, OF ΓΨ, WHO SURPRISED ME WITH A FEW QUESTIONS RECENTLY AFTER HE HAD READ THE OFFICER'S HANDBOOK. THE HISTORY WILL BE EXTENDED OVER THE COURSE OF THE YEAR, AS WE HAVE TEXT UP TO 1978 ALREADY. CONTRIBUTIONS FOR THE YEARS 1978-1986 (PRESIDENTS SOWCHUCK, CROSBY, MARTIN/ARTHUR, KUCH) WILL BE GLADLY ACCEPTED.

MAILING LISTS - THE ACTIVE LIST WILL BE ISSUED AS SOON AS WE GET ONE QUARTERLY REPORT FROM EACH CHAPTER (GET TO IT PRESIDENT'S. YOU'LL FIND THE FORM IN YOUR SECTION OF THE OFFICER'S HANDBOOK). AS FOR AN ALUMNI LIST, I WOULD HOPE THAT BROTHER'S PICARDAT AND JAMIESON COULD COMBINE THEIR RESOURCES AND PRODUCE ONE OFFICIAL LIST. I DO HAVE A PS/1 OF MY OWN NOW, SO I MAY BE OF SOME ASSISTANCE IF NECESSARY. THE IBC WOULD VERY MUCH LIKE TO HOLD AN ALUMNI REUNION IN THE NORTH AROUND MAY/94, SO THE LIST WOULD HELP CONSIDERABLY.

JEWELLERY AND PARAPHENALIA - GAMMA ETA RECENTLY RECEIVED A CONSIDERABLE ORDER FROM BALFOUR, THE FIRST OF MANY SUCH ORDERS I HOPE. AN UP-TO-DATE PRICE LIST IS AVAILABLE, AND A DISPLAY CASE OF ALL OUR OFFICIAL JEWELLERY CAN BE SEEN AT ANY OFFICIAL FUNCTION IN THE NEAR FUTURE. AS FOR PARAPHENALIA, THE IBC HAS NOTHING, THOUGH SHINGLES ARE HIGH ON THE PRIORITY LIST. IDEAS FOR NEW ITEMS ARE ALWAYS BEING ACCEPTED.

IBC MEETINGS

THIS YEAR THE MAJORITY OF MEETINGS WILL BE HELD AT THE RESIDENCE OF THE PRESIDENT (NOW THE RESIDENCE OF THE NVP AS WELL) ON A BI-WEEKLY BASIS. THESE WILL BE ON SUNDAY EVENINGS AT 7PM. UPCOMING MEETINGS TO BE HELD ON OCT. 10, 24, NOV. 7, 21.

WHO SHOULD BE CONCERNED ABOUT THESE MEETINGS YOU MAY ASK? SO FAR WE HAVE REGULAR ATTENDANCE BY MYSELF; THE NVP

CHRIS BURNIP; MY BRO KERRY DECKER, N. SECRETARY; AND THE VICE-PRESIDENT OF EXPANSION AND RE-ACTIVATION, JUSTIN NELSON.

NEXT WE WOULD EXPECT TO SEE OUR HISTORIAN, CHRIS LAUBACH, AND OUR EDITOR, SCOTT MELLOR. CHRIS DID ATTEND ONE OF OUR MEETINGS AND HAD A GOOD IDEA OR TWO, BUT THE FACT THAT THERE IS NO SUBMISSION HERE SHOWS THOSE IDEAS ARE STILL IDEAS. ATTENTION SCOTT : YOU'RE 'A FEW WEEKS' WAS UP A FEW WEEKS AGO. IF YOU STILL WANT THE JOB, CALL SOON.

AND NOW FOR THE SOUTH. BROTHERS MICHEAL ECKSTEIN AND ROBERT PEDEN ACCEPTED THE POSITIONS (TEMPORARY APPOINTMENTS) AS INTERNATIONAL REPRESENTATIVES FOR BETA ALPHA AND BETA PI CHAPTERS, RESPECTIVELY, AT CONVENTION '93. I WOULD HOPE THAT THESE TWO BROTHERS HAVE BEEN ACTIVELY INVOLVED IN ASSISTING THEIR CHAPTERS TO KICK OFF THE NEW YEAR, BUT SINCE I HAVE HEARD NOTHING I CAN ONLY SPECULATE. IT WOULD BE NICE TO HEAR FROM YOU BOTH DURING UPCOMING IBC MEETINGS TO HEAR WHAT'S UP.

WHAT ABOUT GAMMA ALPHA ? WHEN CAN WE EXPECT AT LEAST AN INTERNATIONAL REPRESENTATIVE FROM Y'ALL ? IF YOU HAVE A BROTHER INTERESTED IN SUCH A POSITION, GIVE US A CALL.

AND LASTLY, WE WOULD BE HONOURED TO HEAR FROM THE ACTING BOARD OF TRUSTEE CHAIRMAN, R. "JACK" KITA, DURING A MEETING AS WELL.

EXPANSION / ΓΣ

ADDRESSING THE MATTER OF GAMMA SIGMA FIRST, WHAT I HAVE BEEN CALLING A DONE DEAL IS NOT SO DONE AFTER ALL. IT APPEARS THAT THEY HAVE RECONSIDERED AND ARE NOT FUNCTIONING AS A CRESCENT CLUB AT THIS TIME. INFORMATION IS INCOMPLETE, BUT I WOULD SAY THAT THEY ARE QUITE CONFUSED AND DO NOT REALIZE THE OPPORTUNITY THAT THEY ARE PASSING BY. IF ONE OF YOU READS THIS, I WOULD SUGGEST YOU CONSIDER THE REASONS YOU GAVE TO US FOR WANTING TO JOIN IN THE FIRST PLACE, AND THEN CONSIDER IF ANY OF THOSE REASONS HAVE CHANGED (EG. BEING A CHAPTER WITH NEITHER AN INTERNATIONAL BOARD NOR EVEN ONE OTHER ACTIVE CHAPTER THAT YOU KNOW OF). I WOULD LIKE TO ATTEND A MEETING SOON AND GET SOME SORT OF CONCRETE DECISION ON THIS ASAP, SO CALL IF ANY INTEREST STILL EXISTS.

AS FOR THE REST OF CIVILIZATION, THE GAMMA PROJECT WILL COMMENCE IN THE COMING WEEKS WITH AN ORIGINAL TARGET LIST OF APPROXIMATELY TEN SCHOOLS WITHIN A THIRTY MINUTE RADIUS OF ST. CATHARINES, ONTARIO, PRESENT HEADQUARTERS AND OPERATIONAL CENTER FOR GDP'S EXPANSION EFFORT (THIS LIST WILL INCLUDE NIAGARA FALLS, NY). IF ANYONE HAS CONTACTS OR SUGGESTIONS, PLEASE CALL THE VP OF EXPANSION AND RE-ACTIVATION, JUSTIN NELSON.

TRUSTEES / TRUST FUND

AS HAS BEEN STATED, THERE ARE PRESENTLY FIVE OFFICIAL TRUSTEES (THE FOUR ELECTED AND MYSELF). THIS MEANS THAT THERE ARE FOUR POSITIONS WHICH NEED TO BE FILLED REAL SOON. IF ANYONE IS INTERESTED IN, OR HAS A SUGGESTION FOR, THE POSITION OF TRUSTEE, FEEL FREE TO CALL OR WRITE.

THIS BRINGS US TO THE "FORMER" BOARD OF TRUSTEES, THOSE WHO CONTINUE TO CONTROL THE TRUST FUND. THIS LIST INCLUDES BROTHERS BRUCE JOHNSTONE, SCOTT CROSBY, GERRY THOMPSON AND DON SOWCHUCK. MARK LAMINMAN WOULD BE ON THIS LIST, BUT HE HAS ACCEPTED A POSITION ON THE PRESENT BOT. BROTHER DON SOWCHUCK AND MYSELF HAVE BEEN IN CONTACT OF LATE AND HAVE DISCUSSED THIS ISSUE. THEIR POSITION AT THIS POINT SEEMS TO BE LIGHTENING UP, ALTHOUGH I AM UNSURE TO WHAT EXTENT. SOWIE AGREED TO ASSIST IN OBTAINING THE FUNDS FOR OUR INVESTMENT EFFORT, BUT AT THE SAME TIME DID NOT AGREE OUTRIGHT TO PROCEED TO HAVE THE TRUST FUND TURNED OVER TO IT'S PROPER 'TRUSTEES'. AS I TOLD SOWIE AT ONE OF OUR MEETINGS, WHAT I REALLY WANT IS A LITTLE PARTICIPATION. THE FRATERNITY CANNOT AFFORD TO HAVE A NON-PARTICIPATORY BOT AT THIS TIME. SOMEHOW, BETWEEN THE PRESENT BOT, THE FORMER BOT, AND HOPEFULLY THE GRAND BROTHERS, WE CAN ALL DECIDE ON WHAT IS BEST FOR THE FRATERNITY AND PROCEED FROM THERE. THIS IS ESSENTIAL TO THE COHESIVENESS OF GDP AND OUR ABILITY TO DEAL WITH THE EXPANSION EFFORT WE HAVE PLANNED.

WITH RESPECT TO THE LATEST DECISION OF THE CONVENTION, THIS IS SIMPLY A LAST DITCH EFFORT TO SHOW THE FRUSTRATION WITH THOSE WHO CONTROL OUR TRUST FUND FROM A DISTANCE. I HAVE NEVER EXPRESSED A DESIRE TO CONTROL THIS FUND DIRECTLY, BUT THERE IS LITTLE ELSE WE CAN DO (OTHER THAN SIGN THE FUND OVER TO THE 5 PRESENT TRUSTEES) SHORT OF LEGAL ACTION, AND SUCH A DOCUMENT WOULD BE REQUIRED FOR SUCH AN ACTION. THIS IS NOT MY FIRST CHOICE, BUT AFTER 8 YEARS OF THIS, IT WILL END ONE WAY OR ANOTHER. I WILL NO LONGER ACCEPT STATEMENTS LIKE "THEY'LL SPEND IT ON BEER", OR "THEY'LL SPEND IT ALL". GAMMA ETA SUPPLIES PLENTY OF BEER AND WILL PROBABLY HAVE AS MUCH IN IT'S OWN ACCOUNT AS THE TRUST FUND BY NEXT YEAR.

ALUMNI / GRAND BROTHERS

AS THIS ISSUE OF THE GRIP IS CONCERNED WITH 'BUSINESS-AT-HAND', ALL I WOULD SAY TO Y'ALL IS PERHAPS A SUGGESTION TO TAKE A FEW MINUTES AND WRITE TO A YOUNGER BROTHER. NOTHING IS MORE INSPIRING THAN TO RECEIVE UNEXPECTEDLY A LETTER FROM A BROTHER YOU NEVER MET THAT TALKS ABOUT FRATERNITY AND LIFE. JUST ASK

ANYONE THAT EVER RECEIVED A LETTER FROM MALCOLM. AS ALUMNI THE FRATERNITY ASKS LITTLE OF Y'ALL, BUT A LITTLE IS ALOT THESE DAYS.

SPECIFICALLY TO THE GRAND BROTHERS, YOUR ASSISTANCE IS REQUIRED IN OUR BOT DISPUTE (PLEASE). WRITE TO ANY INVOLVED AND HELP US SOLVE THIS THING.

I'M SURE THERE IS MUCH MORE TO BE SAID, BUT THIS IS MUCH MORE THAN I HAVE EVER WRITTEN FOR ONE GRIP, AND IT IS 12:26 PM ON SATURDAY OCTOBER 16, 34 MINUTES BEFORE THE RALLY, SO I MUST BE GOING.

ALL I CAN DO AS AN INDIVIDUAL BROTHER FOR THIS FRATERNITY I HAVE ATTEMPTED TO DO. IT IS NOW UP TO THE REST OF THE CRESCENT TO DO THEIR PART FOR THE ADVANCEMENT OF OUR CAUSE, NAMELY THE SPREAD OF OUR BROTHERHOOD AND ADVANCEMENT OF THE IDEALS WE ASSOCIATE WITH IT.
